
Welcome Kyle to the Conservation District

My name is Kyle Schutt and I am the Mosquito-Borne Disease Control Technician here


in Schuylkill County. I graduated from Shippensburg University with a Bachelor's degree in Biology with a concentration in Ecology and Environmental Biology. I started here at the Conservation District in early May and have been monitoring mosquito populations at various sites across the county.

All mosquitos are collected and shipped to Harrisburg where they are identified and tested. This monitoring will give me a better understanding of the populations in the county and how I can best control

them to make the county as safe as possible for the public.

Hawk Mountain Sanctuary Online Kestrel Cam Goes Live

For the fourth year, Hawk Mountain Sanctuary in Berks County is hosting a 24/7 live stream via

a camera mounted within a local American Kestrel nest box installed by the Sanctuary. The American Kestrel Nest Box Program is part of Hawk Mountain's long-term study of kestrel reproductive ecology, now in its 65th year.

The Kestrel Cam streams from a nest box on a private farm local to the Acopian Center for Conservation Learning, and it runs from about mid-March to the end of



June, dependent on the nesting pair and their chicks. The recorded footage is then trimmed and used for Hawk Mountain's Act 48 approved American Kestrel Webcam Curriculum. The curriculum is designed for elementary and middle school levels with a focus on kestrel nesting ecology and interactive technology. The American Kestrel Nest Box Program provides outreach to the local community and hands-on training for spring conservation science trainees and interns, including experience in data collection, banding, and live nestling handling and documentation. Today, more than 200 kestrel nest boxes have been placed within a 25-mile radius of Hawk Mountain, and each year all boxes are cleaned and monitored. Successful nestlings are banded at two weeks of age to continue the long-term research. - Bicentennial farms have been recognized in 40 of Pennsylvania's 67 counties.
- More than 245 farms recognized by the program were established in the 1700s.


- Sunday, January 28th, 8:00 a.m.-1:30 p.m., "Stump Dam". "Hiker Jim" Murphy will take you to the Gumboot then Black
 Diamond Road to Blackwood and then Stump Dam. You'll follow the old Lehigh Railroad to Silverton. Meet at Llewellyn
 Hose parking lot. (9 miles, easy) This walk goes on even with light snow on ground.
- Sunday, January 28th, 2:00-4:30 p.m., "Fort Dietrich Snyder and Appalachian Trail". Located on top of Blue Mountain
 at Rte.183. A short hike to a monument for the fort location. See a natural spring along an abandoned farm pond and continue to hike the AT. Meet at Rte. 183 on top of Blue Mountain. (3 miles, easy)
- Saturday, February 24th, 10:00-11:00 a.m., "Cabin Fever Walk". "Porcupine Pat" guarantees that this walk will cure your fever! Meet at the Waterfall Road parking lot of Sweet Arrow Lake Park. (3 miles, moderate)
- Sunday, February 25th, 8:00 a.m.-1:30 p.m., "County View". "Hiker Jim" offers plenty to see including the "88" and diversion canal plus "The Old Jerk" and a spectacular view of County Schuylkill. Meet behind Mt. Pleasant Hose Company in Buck Run on Rte. 901. (8.4 miles, easy)

- Saturday, April 14th, 10:00 a.m.-4:00 p.m., "Rausch Gap". State Park Education Specialist Robin Tracey takes you on a hike up the mountain and across to the Village of Rausch Gap. There will be one difficult stream crossing. You'll be taken back in time! Meet at the concrete pad at the state game lands parking lot on Gold Mine Road off Rte. 443 outside of Pine Grove. Bring a lunch and dogs are welcome but must be leashed. (9.5 miles, difficult)
- Sunday, April 15th, 1:00-3:30 p.m., "Peak Experience". Traverse the top of the Blue Mountain above Port Clinton on this trek that features an overlook and charcoal history. Meet "Porcupine Pat" at the entrance to Conrad Weiser State Forest along Rte. 61 northbound just north of Port Clinton. (3-4 miles, moderate)

- Saturday, July 7th, 2:00-4:00 p.m., "Rte. 61 Schuylkill River Trail Segment". Hike a new stretch of the Bartram Trail, aka Schuylkill River Trail, with "Porcupine Pat". Scenic views from Tumbling Run to Seven Stars. Meet at the Schuylkill County Ag Center for carpool to the trailhead. (2 miles, easy)

- Saturday, August 11th, 1:00-4:00 p.m., "Swatara State Park Stroll". Hike the Swatara State Park with Mike Centeleghe to view natural beauty and see some of nature's edibles. Open to all ages. (3 miles, moderate)
- Saturday, August 18th, 10:30 a.m.-3:30 p.m., "Long Loop Hike". You will hike with Robin Tracey on most of the trails in Tuscarora State Park. See great lake views and cross the dam breast. We finish our hike on the Spirit of Tuscarora Trail. Dogs must be leashed and bring a lunch. Meet at the Crow Trail parking lot at Tuscarora State Park. (8 miles, moderate)

(8 miles, moderate)
- Sunday, August 26th, 2:00-4:00 p.m., "Frackville Foray". Hike leader John Domalakes showcases the grave of Frackville founder Daniel Frack and then an awesome overlook of the Mahanoy Valley. Meet at St. Joseph's Church on North Line Street, Frackville. (3 miles, easy)
- Monday, September 3rd, 10:30 a.m.-3:30 p.m., "Wolf Creek Falls & Reservoir Hike". Meet Robin Tracey at the east end of the Wal-Mart parking lot in Saint Clair. You must register for this walk by calling Robin at 570-467-2506. A hidden gem! Bring a lunch and dogs must be leashed. (7.5 miles, difficult)
- Sunday, September 9th, 1:00-4:30 p.m., "Mystical Red Hole Ramble". Hike leader John Domalakes leads this tour that
 features this historic site from the 1750's French and Indian War. Meet in the parking lot of the Schuylkill County Ag Center, Rte. 901, Pottsville for carpool to the trailhead. (3-4 miles, moderate)
- Sunday, September 16th, 8:00 a.m.-1:30 p.m., "Mine Hill to Mine Hill Gap". "Hiker Jim" offers another view of Broad Mountain. See strip mine regrowth, the "black desert", Mine Hill Gap and views of Heckscherville Valley. Meet at Sunbury Road and Hillside Road. (7 miles, easy)
- Saturday, September 22nd, 9:00 a.m.-4:00 p.m., "The Pinnacle". Gorgeous views from the top of Blue Mountain. Meet

 walk by calling Robin at 570-467-2506. Bring a lunch. No dogs please. (11 miles, difficult)
- Saturday, October 6th, 10:30 a.m.-3:30 p.m., "Lebanon Reservoir and Swatara Furnace". Robin Tracey leads you on
 this historic and scenic tour. Meet at the concrete pad at State Game Lands off Gold Mine Road. See a large reservoir and
 follow the old railbed and then drive to the Swatara Furnace. Bring lunch and dogs are welcome. (7 miles, moderate)
- Sunday, October 7th, 1:00-4:00 p.m., "Walk in Penn's Woods—Tuscarora State Park". Walk in Penn's Woods aims to get people out to enjoy the woods and to learn about how these woods work for us from recreation and wildlife habitat to seeing the outcomes of timber harvests. 




While you're here, please take a moment and sign up to get email updates to find out what's going on in your neck of the

woods as well as get key updates to the 50th anniversary. (Editor's note: Locally, the internationally-acclaimed Appalachian Trail, for the most part, forms the southern boundary of Schuylkill County.)

The Wild & Scenic Rivers Act also celebrates its 50th anniversary. In the days of fur trappers and pioneers, free-flowing rivers were the lifeblood of commerce, transportation and fisheries across America. Today, they are critical yet often-overlooked sources of clean water, critical habitat, and rejuvenating recreation for Americans seeking a break from the frenetic world of technology and reconnection with the deep flow of time and nature. Across the nation, river enthusiasts, communities and government agencies are preparing to celebrate wild rivers with the 50th anniversary of the passage of the Wild & Scenic Rivers Act.

Congress passed this landmark legislation on Oct. 2, 1968, to preserve selected rivers



Of the approximately 3.6 million miles of streams in the U.S., less than one quarter of one percent – 12,734 miles – are protected by the Wild & Scenic Rivers Act. These miles include some of the most primitive and breathtaking land-scapes in North America.

Meet Briana Luckenbill, 4-H Educator

How long have you served as educator and what is your personal background in 4-H?

Î have been the 4-H Educator in Schuylkill County since June 1, 2005. My background: Schuylkill County 4-H Alumni: Livestock Programraised market hogs, market goats, market lambs, market steers, dairy goats, and Breeding Boer goats. I've attended numerous 4-H leadership conferences, attended 4-H Camp, served as a 4-H Camp Counselor, and served as the 4-H Summer Intern in 2002, 2003, and 2004 while in college.

4-H provides many opportunities for a young person to grow while learning by doing. How does your role as coordinator make these opportunities possible?

4-H gives youth the opportunity to be themselves. To learn, grow, and explore what interests them here and now. It allows them the chance to make friends with other youth and adults who have similar interests. What I see in my club members is outstanding growth and potential. Watching them grow from a shy or quirky adolescent to a teen leader within their club and community that is ready to take on "real world" experiences with confidence and maturity. 4-H is the pathway to the future. As the coordinator, I am organizing and promoting the opportunities that the youth have available to them. However, it's the 4-H Volunteers that make it happen. They are the individuals that make the program grow and thrive. I provide the opportunities and the volunteers are the individuals that work with the youth one on one and encourage them to attend the event

Why is 2018 is a special year for Schuylkill County 4-H? This year marks 100 years of 4-H programming in Schuylkill County. Our local 4-H program was established in 1918 and is now serving nearly 2,000 youth and leaders in Schuylkill County annually. Today, 4-H is about much more than corn and cows. It covers just about every area of interest, from animals to workforce preparation, and from woodworking to the performing arts. While agriculture, horticulture,

and family and consumer science remain strong projects in 4-H, new interests, such as environmental science and engineering, are now included.

Do you have a favorite 4-H story?

I will never forget the time I was attending 4-H Camp as a camper. I must have been around 10 years old. I attended camp with Schuylkill County but our county also attended camp with Carbon County 4-H. My father was the staff member from Carbon that year, so I was fortunate that I got to camp with my dad. Unfortunately, I became very homesick and cried every night. Each day I was perfectly fine. However, each night I cried. The counselors did not know what to do because they thought it was odd I was homesick when my father was already at camp. They would take me to my father in hopes of consoling me. My dad would ask why I was crying when he was there and I would cry back to him that I didn't want him, I wanted mom. Oh boy, my dad would laugh because he couldn't understand why I was homesick when I was lucky enough to have a parent at camp. Now as an adult and as a 4-H Educator, I realize how unsettling it is for a child to sleep away from home at camp. I am compassionate about it more then I believe others are because of my homesickness. However, I know the growth I went through because of that experience and am more apt to work with those kids that might be struggling. But as an adult now, I look back at my personal experience and laugh at my situation. It was comical because I was lucky to have a parent at camp. It just was not the parent I wanted at camp.



I did however camp with my father for almost two decades. First as a camper, next as a counselor and lastly as a 4-H staff member before he retired. Those were some of the best memories I have of 4-H and spending time with him. That's what makes 4-H so special. It's a program that allows families to work and participate together.
