


MANAGER'S CORNER





Independent review hails management of Pennsylvania's state forests

PA Department of Conservation and Natural Resources Secretary Cindy Adams Dunn has released results of an independent review team's annual study of state forestlands, noting its findings continue to affirm Bureau of Forestry efforts to conserve these resources through sound management." Once again our state forests were deemed 'well-managed' in an official certification reflecting the pride we take in overseeing our state forest system for many values and uses, while maintaining its long-term health and viability," Dunn said. "Auditors were very pleased with our management and dedication of staff, and I extend thanks to districts involved in this year's audit for another job well done."

For the 17th consecutive year, since 1998 when a team of scientists first began reviewing management of the 2.2 million acres of state forestlands, researchers applauded Pennsylvania's commitment to its forests, and exemplary practices and innovation in managing forest resources. "Forest management faces many threats and challenges, including fragmentation and disturbance, invasive plants, destructive exotic insects and challenges with regeneration," noted Dunn. "The certification process shows we are doing everything we can to improve our management plans and practices. More importantly, it helps us identify areas we can improve to ensure our forests are well-managed and in line with public expectations."



Ending Sept. 2, the three-day Annual Surveillance Audit was conducted by Scientific Certification Systems (SCS), an Emeryville, California based certification

body accredited by the Forest Stewardship Council (FSC) to conduct forest management and resource evaluations. An SCS project team consisting of two foresters specializing in wildlife biology, ecology, forestry management and socio-economic issues toured Rothrock, Bald Eagle, Weiser, and Pinchot state forest districts. They met with DCNR staff, scoring forests on timber-resource sustainability, forest-ecosystem maintenance, financial and socioeconomic considerations and other FSC indicators.

The audit team visited timber sales, recreational trailheads, research areas and a mine reclamation area. Auditors sought district input on effects of energy extraction; deer impact in the forests; forest regeneration; and bureau public input and education efforts. Their study focused on public involvement; timber harvests; chemical use; landscape considerations in timber sales; soil, wildlife and other ecological safeguards; and use of non-native species.

Certification assures consumers that wood products from the state's public forests come from a sustainable, well-managed system, which helps Pennsylvania to compete in the growing niche consumer market for "green" label wood products.

Update on trail projects

Hiking trails are popular in Schuylkill County especially since the Appalachian Trail for the most part comprises the southern border of our county. Two initiatives are being pursued by the Conservancy. One is the almost 7-mile long Blackwood Trail that is in cooperation with the Schuylkill County Municipal Authority that owns the land. A grant has been submitted to the state but the budget impasse has stalled efforts.

The other trail being developed is in cooperation with the Borough of Schuylkill Haven and parallels Rt. 61 from the Seven Stars Road exit ramp to Tumbling Run. The water line for Schuylkill Haven runs underneath this trail and is 1-1/2 miles in length. This will be in cooperation with the Schuylkill River Heritage Area that is developing the Schuylkill River Trail from Philadelphia to Pottsville area. This segment will be part of that trail development work. Two Memoranda of Understanding have been signed with the Borough and the Heritage Area to detail specifics to trail development.



Thanks to Blue Mountain High School especially to Melissa Gehman and her Lifeskills students for working on the Rt. 61 path. They cleaned up litter, trimmed overhanging branches and helped smooth the trail.

National water quality database released to address nutrient challenges

The National Corn Growers Association and the Water Environment Research Foundation announced the completion of the Agricultural Best Management Practices Database at the American Water Resources Association's Annual Conference on Water Resources. Along with other project sponsors, such as the United Soybean Board, this database was developed to create a centralized repository of agricultural best management practice performance studies related to water quality in agricultural areas.

"The goal of the database is to provide farmers, agricultural advisors, planners, and consultants with information that enables them to implement cost-effective water quality improvement solutions," said NCGA Production and Stewardship Action Team Chair Brent Hostetler. "Currently, many conservation practices and pollutant reduction measures are being voluntarily adopted. However, until now, the effectiveness of various practices has been uncertain due to the limited availability of comprehensive and comparable field-scale data. The Agricultural Best Management Practices Database addresses this problem by providing a comprehensive set of monitoring and reporting protocols and a clearinghouse for collecting, storing, and evaluating agricultural best management practice performance information."



"WERF appreciates the proactive approach that NCGA and USB are taking with creation of the Ag BMP Database," explained WERF Research Program Director Theresa Connor. "Having a clearinghouse of meta and performance data for agricultural conservation practices will assist both growers and watershed managers make more informed decisions on the impact of their conservation practices on water quality, and as information is available costs and crop yield. Bringing the many available, diverse research projects into one data system can ultimately help growers more effectively implement conservation practices and researchers share information."

The database includes performance data and metadata that document the many variables that affect BMP performance. These variables include geographic area, field conditions such as soils and slopes, tillage and nutrient management practices, and the existence of buffers, constructed wetlands, and other edge-of-field practices. The database's initial release focuses on row crops, particularly corn and soybeans, and its primary analytical focus is on phosphorus, nitrogen, and sediment.

- CONCOLOR FIR: Extremely popular tree in past sales. Excellent ornamental or Christmas tree. Has flat, soft green to
 deep blue citrus-scented needles. Hardy because it withstands dry periods and high temperatures. 4 year old seedlings. Size: 8-16."
- NORWAY SPRUCE: Fastest growing of the spruces. Develops pyramidal shape and strong graceful branches that are covered with dark green needles. Ideal windbreaker that likes full sun and grows in various soils. Matures at 60 feet and has a beautiful 25 foot spread. 4 year old seedlings. Size: 10-24."
- **BLACK HILLS SPRUCE:** Desirable, symmetrical cone shape to this conifer. Dense bright-green needles mature to an interesting blue-green. Great landscape accent, useful as windbreak or screening. Browsed by mammals and attracts birds. Serves as a good yard or ornamental tree either solo or in a group. 5 year old seedlings. Size: 10-24."
- AUSTRIAN PINE: This is an extremely tolerant pine of adverse soil conditions. This stately tree can be seen in parks, along streets, in residential landscapes, and as farm windbreaks throughout much of the United States. Landscapers use the dark beauty of these trees for backdrops, but it is also an excellent specimen tree because of its leaf pattern. Can grow up to 60 feet high with a 20-40 foot spread. 4 year old seedlings. Size: 10-28."
- AMERICAN ARBORVITAE: This slow-growing tree prefers full sun to partial shade but adapts to a variety of soil conditions. Prefers moist soils but can withstand drought. It grows to a mature height of 25-40 feet, and has a mature spread of 10-15 feet. Makes a good wind-block and provides cover for all types of wildlife year round. 3 year old seedlings. Size: 6-12."
- **RED MAPLE:** This maple grows at a moderate to rapid rate and does best in bright sun to partial shade. It will grow in a range of soil types from sandy loam to clay. Better soil will result in a better healthier tree. The tree has a pyramidal shape when young. When tree matures it will attain a larger more rounded crown and will grow to a size of 40-60 feet with a width of 25-45 feet. Leaves turn a brilliant red during fall and accent any yard. 2 year old seedlings. Size: 5-10."
- **RED OAK:** Very popular landscaping tree for shade on lawns, parks and golf courses. This oak is fast growing and easy to transplant. It is tolerant of urban conditions including dry and acidic soil and has abundant acorns that attract wildlife. Leaves turn a brilliant brick-red fall color and adds color to a forest. This tree has been used in mine reclamation sites for revegetation purposes. 2 year old seedlings. Size: 10-24."
- **TULIP POPLAR:** This tree is considered both a shade tree and an ornamental tree. It features a spreading canopy capable of blocking sunlight and adds visual interest and beauty to landscaping. It is the tallest of the eastern hardwoods—and a rapid grower when conditions are right. 2 year old seedlings. Size: 10-28."
- AMERICAN CRANBERRY: Popular seedling the last three years! This is an excellent deciduous shrub for screening up to 10 to 12 feet high. It grows to a width of 8 feet with very dense growth of up to 3 feet per year in full sun or part shade. This bush has showy white flowers in spring followed by red berries in fall and winter. Berries hang through mid winter making excellent bird feed. This shrub has very few insect problems and prefers good, well-drained soil. For best growth, provide supplemental water during dry periods. For a solid screen, plant bushes 2 to 3 feet apart. 3 year old seedlings. Size: 10-22."
- FORSYTHIA: Beautiful yellow-flowered shrub that is fast-growing to about seven feet tall. Tolerates poor soil and city conditions. Good for screens and hedges and cover for birds and small wildlife. 3 year old seedlings. Size: 10-24."
- WINTERBERRY: Winterberry is a deciduous shrub growing to 6-15 feet tall and often as wide. It develops a rounded habit through suckering, eventually growing into a sizeable colony of upright stems. The stems tend to be dark brown and often develop a pleasing gray sheen. The 3 inch long, elliptic, toothed, and pointed leaves vary from light to dark green, taking a yellow hue in autumn. Insignificant flowers appear in May June and are followed by bright red berries in late summer. The berries, for which the common name was derived, remain after leaf fall and persist into the winter months to provide food for wildlife. Winterberry prefers evenly moist, acid soils in full sun to partial shade. 3 year old seedlings. Size: 8-18."
- COMMON LILAC: A medium to large hardy shrub with stout, spreading branches developing an oval to irregularly-rounded crown. The showy flowers are fragrant and enjoyed each spring. 3 year old seedlings. Size: 10-20."
